Bizarre treasure saga ends with large jury verdict

Won a \$16.4 million verdict after three-week jury trial against Tommy Thompson, the notorious treasure hunter who found the wreck site of the *S.S. Dismantling of a \$42 million jury verdict

Successfully argued before the Ohio Supreme Court for reversal of \$42 million verdict and establishing the law in Ohio as to the application of the covenant of good faith and fair dealing in contracts.

Secured writ of mandamus action

Successfully argued before and secured from the Texas Supreme Court a writ of mandamus requiring a trial court to correctly apply a forum selection clause and to dismiss the defendant; a decision which clarified Texas law as to the application of forum selection clauses.
